Who We Are

The Family Violence Legal Service Aboriginal Corporation (SA) is an Aboriginal Community Controlled Organisation.

We provide legal help and non-legal support for Aboriginal families.

Our service is free and confidential.

We work in a culturally safe and trauma informed way.

Our team includes a CEO, admin staff, lawyers, client support officers, a board of directors and a membership base from our community groups.

Who We Help

Aboriginal and Torres Strait Islander victim-survivors of family and domestic abuse and sexual assault.

Parents or carers of Aboriginal and Torres Strait Islander children.

Families and Communities that are affected by violence.

We cannot help perpetrators of family and domestic abuse and will refer them to another service.

What We Do

Non-legal client support; and
Legal information, advice and representation in:

- Family Law – parenting, some divorce and property matters;
- Child Protection;
- Victims of Crime Compensation – where it relates to domestic, family or sexual violence; and
- Intervention Orders – private applications, some variations.

We take part in law reform and policy work to make sure the voices of victim-survivors of family, domestic and sexual violence are heard.

How We Help

We offer phone, video and face to face appointments.

Our lawyers can:

- Give legal advice and options;
- Write letters;
- Help with Court documents; and
- Go to Court with you.

Our Client Support Officers can:

- Give information and referrals;
- Go to appointments and meetings with you;
- Help you find support services; and
- Help with completing forms.


Programs and Events
