# WHAT IS: The Royal Commission into Institutional Responses to Child Sexual Abuse

The Family Violence Legal Service Aboriginal Corporation (SA) (FVLSAC) is holding some information sessions with a lawyer from Knowmore legal service and a counsellor from the Victim Support Service to tell people more about the Royal Commission into Institutional Responses to Child Sex Abuse.

The Royal Commission is hearing stories from lots of different people about the things that happened to them when they were children. The institutions that the Royal Commission is looking into include schools, churches, foster care arrangements or homes for kids, sporting clubs and scout groups. These are all places where kids should be able to feel safe and happy.

The Royal Commission is looking into some of the things that happened to kids at these places and how these things were responded to by the institutions.

From the information gathered the Royal Commission will be making recommendations about things that should be done differently in the future to try to make sure that things like this can never again happen to kids.



IT'S NEVER TOO LATE TO REPORT!!! WE CAN HELP IF YOU WANT TO TALK TO SAPOL!!



Sexual assault is making people do sexual acts against their will. This includes any intimate contact like kissing and touching in unwanted places.

Rape is when someone has sex with another person who does not consent or has withdrawn their consent.

What does consent mean? Consent means to agree and say yes!

A person is ONLY consenting to have sex if they are doing so FREELY and because they WANT to (hungady way!)

The law says that a person does not consent if:

Let's talk about sex! Well, actually about sexual assault.....

- They have been threatened and they are scared to say no.
- They have been locked up by the other person.
- They are asleep or passed out.
- They are so drunk they cannot agree or disagree with sex happening.
- They have a mental disability

- They don't understand it is sex (eg they think it is a medical examination).
- They want to have sex but they think it is with someone else.
- They did want to "fool around" a bit but not to have full sex.....
- Anything less than FREE CONSENT could be seen as a rape by the law now.....

There is no time limit to report sexual offences!

YOU CAN REPORT A RAPE OR SEXUAL ASSAULT EVEN FROM MANY YEARS AGO!

ORT APE OR UAL ULT VEN LOM ANY ARS and given punishments for crimes that happened years ago......

If you want to talk about something that happened years ago there are a number of ways you can do it......

You can talk to one of our solicitors.....we can tell you about your options, including going to the police if you want to do that.

You can talk to the Royal Commission into Institutional Responses if you were in a home or institution as a child and you were sexually abused....

Our service will be running workshops soon with Knowmore — a free legal service set up to help people with the Royal Commission — and Victim Support Services. — Come along and have a yarn with us!

## When is too young to have sex by law?

Some people think it is okay for kids aged 16 years old or even younger to have sex. Many different cultures through the years have also thought this......

NOW the law says a person has to be 17 years of age to be old enough to consent to sex.

If one person is under 17 and the other person is over 18 then the older person could get charged with an offence. This is called Unlawful Sexual Intercourse. The reason the law says this is because in South Australia the law says kids should be able to grow up and not have to worry about adult things until they are mature enough to handle the results. After all, sex can lead to lots of consequences such as babies! Even if a kid thinks they are old enough, if their partner is an adult the chances are the adult will have all the power in the relationship and this can lead to trouble and abuse.

The law wants kids to be kids as long as possible.

The law wants kids to wait because it is well known that young people take risks and do things they later regret.

The law tries to make kids "off limits" to any adults who want to have sex with them.

The law places harsh penalties on adults who have sex with kids and they will be charged, sentenced and treated as a child sex offender.

#### BETH'S SPICY DAHL RECIPE

#### Peanut oil

One large brown onion (chopped up fine)

Ginger, a thumb sized bit, shredded

2-3 cloves garlic, finely chopped

Couple of pinches of salt

I cup red lentils

2 tablespoons tomato paste

4-5 cups water

1 can or 5 chopped tomatos

Juice of one lime

Bit of fresh coriander

- 2 teaspoons mustard seeds
- 1 teaspoon fenugreek
- 1 teaspoon coriander seeds
- 1 teaspoon cumin seeds
- 6 whole cloves
- 4 whole cardamom pods
- 2 dried red chillies
  - 1 cinnamon stick

Dry fry spices over a medium heat (not the cinnamon stick) until they are roasted. Crush the spices up. Heat oil in a large saucepan or wok on medium heat. Add onion, ginger and garlic and fry.

Add spices, then lentils, water, salt tomatoes and tomato paste. Cook for 20-30 minutes or until lentils are soft. Add more water if too thick. Take off heat and add lime and coriander. Serve with rice or flat bread YUM!!
